RECEIVAL OF EXPORT CARGO

Hours of Operation: Monday to Friday 0700hrs to 1400hrs

Method of Receival: Cargo & Export Receival Advice is to be presented to R&D Office, located outside the terminal. Cargo is then to be driven into terminal to location specified by R&D Office. All cargo received into terminal is to be self-unloaded (drivable) or suitably glutted for forklift to unload. For cargo that is required to be crane lifted, this must be pre-arranged at least 24hrs prior to arrival by contacting Operations on 07 3909 3027 and operations.fi@aaterminals.com.au, lifting fee to apply.

Requirements at R&D:

- Cargo Markings cargo must be clearly marked with: Vessel Name, Voyage Number, Booking Reference, Cargo ID, Destination Port, <u>Gross Weight, and Dimensions</u> (<u>Length, Width, Height</u>) of cargo
- "Export Receival Advice (ERA)" completed with:
 - Booking Reference Number
 - Vessel and Voyage
 - Port of Load
 - Port of Discharge
 - o Identifying Marks, i.e. VIN / Serial Number etc
 - o Actual Weight & Dimensions (Length, Width, Height)
 - Customs' EDN/CRN
 - Cargo on truck must match ERA

"Used Vehicle / Machinery Checklist" must be completed – https://www.aaterminals.com.au/wp-content/uploads/document//Certification%20of%20Use%20Mobile%20Machinery.pdf

- Used Vehicles Machinery MUST also have starting and stopping instructions in the vehicle
- ALL used vehicles and machinery must be mechanically sound, free of any mud, soil or leaking oil/grease. Dirty or leaking cargo WILL NOT be accepted
- Caravans MUST remove Gas cylinders as they are NOT allowed to be exported

Requirements to enter terminal: Cargo is driven into terminal by Transport, for terminal access all transport MUST have:

- Completed AAT's Site Induction http://www.inductee.com.au/aat/login.php
- Be compliant in AAT's Contractor Management System (Rapid) email <u>contractors.fi@aaterminals.com.au</u> to request an invitation link to Rapid.
- Valid MSIC displayed
 - Please note: Transport without a MSIC can pre-arrange an MSIC escort from AAT by contacting 07 3909 3013 or <u>clerks.fi@aaterminals.com.au</u>. A fee of \$136.34 +GST is payable prior to cargo being received into terminal. ***NB*** This only applies to Cars and Trucks. NO BBLK or Excavators/Wheel loader etc.
 - Please note: AAT can drive in used motor vehicles if required by Transport. This must be pre-arranged by contacting 07 3909 3013 or <u>clerks.fi@aaterminals.com.au</u>.A fee of \$63.01 +GST is payable prior to cargo being received into terminal

<u>Late Receival:</u> Cargo that is not received prior to vessel cut-off must be approved for Late Receival by Shipping Line/Stevedores. For all Late Receival Requests please contact your Shipping Line.
